This will make the area enjoyable for all us. There is also a City Ordinance 5.7.180: Canine Waste: It states the following:
It shall be unlawful and a public nuisance for any person owning or having control or custody of any dog : (A) To permit or allow the dog to defecate upon publicly owned property of the city or upon the private property of another person without the consent of the occupant or owner of that property unless the owner or the person having control or custody of the dog immediately removes the feces and properly disposes of it; (B) To walk a dog on publicly owned property or upon the private property of a person without carrying at all times a suitable container or other suitable instrument for the removal and disposal of canine feces; or (C) To fail to dispose of the container of the feces in a sanitary manner. Violations of the provisions of this section shall be an infraction. (ord.901,6-29-2012). With that said I am challenging all who have four legged sweethearts to be responsible and clean up after them! It will make a difference not only to our neighborhood but the City of McCall.

Last I would like to publicly thank all of you that are on the Board of Directors. Your dedication and time volunteering in the neighborhood is amazing and vital. I appreciate every single one of you. To all my neighbors near and far I appreciate you and have loved getting to know you all better! Thank you all for making this a great place to live!
