WHOA Pool & Mask Requirement Updates July 2, 2020

The Board has been working toward opening the Woodlands Pool with target date of July 3. Unfortunately, we were unable to make this deadline. We are now looking at opening at the latest on the weekend of July 11, hopefully sooner.

I am sure you are aware of the increase in positive cases of Covid-19 in Valley County. Please visit McCall's website or read the Star News for recent developments, restrictions, closures, and cancellations to this year's events.
