Woodland Homeowners:

Happy 4th of July!!

Just a reminder to be "Firewise" with fireworks next weekend. Better yet head to one of the community sponsored displays: Cascade July 2, New Meadows July 3 and McCall or Donnelly July 4th. Displays begin at dusk, check the Star News for exact locations.

We are hoping to have new locks on the pool and tennis courts by Wednesday, June 29th, and at that time keys will be available. Please contact Patti at 208-315-1177 or soucek@frontiernet.net to make arrangements to meet her, sign the required forms and get your new key. There will be only one key per household. If your residence is leased and you want your renter to have access to amenities you will need to contact Patti and supply forms that take full responsibility for them, permission for them to receive the key and provide us with contact information for the renter. We will not provide keys to management companies. If you would like to have your key mailed to you we will be happy to email or mail the required form to you and send the key to the mailing address in our records when it is completed and returned.

With summer here, boats, other water craft, campers, motor homes, etc. come out of storage. This is a friendly reminder that Article IV, section 4.12 page 13 of the Amended and Restated Master Declaration of Covenants, Conditions and Restrictions for the Woodlands allows for these items to remain on your property no longer than 14 days. If it remains on the property longer it must be parked to the side or back of your dwelling and screened from sight of traffic along the subdivision roads. These restrictions apply to other vehicles as well, if you have questions please refer to the CC&R's.
