### WHOA March Board Meeting Minutes

WHOA Board Meeting 3/25/2021  
Meeting called to order at 7:10pm  
Attending: Shauna, Patti, Trish, Jared and George  
Meeting Minutes by Margie

The only topic for discussion at this meeting was the pool and common area. Patti reviewed the protocol that allowed us to open the pool and common area for a short season last year and discussed the CDC recommendations for this year. Following an extensive discussion it was decided that:

1. The pool and common area including tennis, pickleball and volleyball courts will open Memorial Day Weekend and remain open through Labor Day.
2. The hours of operation will be 9am to 7pm. Closing at 7 to allow Patti the time needed to perform cleaning and disinfecting procedures before dark.
3. To reduce cleaning and sanitation, the pool furniture and picnic tables will remain in storage. The clubhouse will be unavailable.
4. No food will be permitted in the pool area.
5. Bathrooms and showers as well as doorknobs, gates and pool railings will be cleaned and disinfected daily.
6. Hand sanitizer will be provided.
7. We will not be taking reservations for the pool.
8. Occupancy will be limited to 15 in the pool area, residents only, no guests.
9. Everyone is asked to adhere to CDC social distancing guidelines.
10. We ask that people limit their time if others are waiting.
11. We will be taking reservations for the picnic area and ask that parties be limited to no more than 50. As stated previously, picnic tables will remain stored. Please be advised that we will follow these rules and guidelines and we will make changes only if circumstances or CDC guidelines change.
