### Follow up: Informal get together on April 17

There was a good turnout at the informal meeting to discuss concerns about the new development of the 68 and 90 acre parcels (the 68 acre parcel has closed and the 90 acre parcel is pending). There were good comments and input from everyone.

Consensus was that safety from dramatically increased construction and residential traffic is our primary concern.

As a result, 5 people volunteered to be part of an "ad hoc" committee to work on this, and there was consensus that an attorney should be retained to represent the neighborhood's interests. The committee will put together an estimate of attorney's fees and present it to the Woodlands HOA Board of Directors for consideration of financial support from HOA funds. A spending cap will be recommended.
